

## ISIC'S FOCUS AND ACTIVITIES

The primary objective of ISIC is to strengthen Japan's defense industrial capacity through business-to-business collaboration and integration of local contractors with the global supply chain



## **KEY TAKEAWAYS FROM DEC 2021 DIF**

- While Academia played key role as member of defense community in US and NATO, based on their free will, to contribute to national security from S&T perspective, in Japan, members of academia community was bound by the ideology which prohibits doing S&T research for military purpose, in contrast
- Lessons learned by US from Cold War days were that defense industries was often influenced from the defense technology/equipment they developed that, providing neutral and unbiased insight and knowledge from pure S&T perspective was something that can only be expected from Academia, which perhaps was something missing in today's Japan.
- While there could be Japan unique hurdles based on its own historical view, ATLA has been making its own effort through "Security Technology Research Promotion System" to create collaborative opportunity between Academia and National Security community, and ideas to explore Japan version DARPA or establish similar research institute like FFRDC and UARC in US was brought up during the webinar as something Japan should take serious look in the future.

## **KEY TAKEAWAYS FROM FEB 2022 DIF**

- Common understanding was confirmed that despite of various effort being made by JMOD/JSDF in the past, declining course of Japan's defense industrial base, who only depended on Japan's defense budget, could not be changed, and this trend remains in effect as of today.
- Recap was made on the objective of 3 principles on transfer of defense equipment/technology, that this was not meant as a rescue plan for the sustainment and strengthening of JDIB, but to offer diplomatic options to promote "Proactive Contribution to Peace Policy". Therefore, LDP study group made policy recommendation that defense transfer for the purpose of sustainment and strengthening of JDIB shall be separately promoted as a national security policy, not just by JMOD, but under the responsibility of the entire government, and explicitly stipulate it in the new National Security Strategy to be prepared this year. (LDP Upper House Member, Ms. Rui Matsukawa)
- However, the discouraging and demoralizing environment inherent to JDIB e.g., having passive business stance due to long history of dealing only with single customer, weakened position within the corporate organization due to the scale and profitability of the business, suppressive corporate executive mentality on defense business caused from fear of reputation risk and negative impact to company valuation, and unilateral judgment by the public for promoting oversea defense business as "Merchant of Death", reconfirmed the necessity of strong teaming between government and industry to overcome the robust brick wall built around JDIB.
- Another highlight was made on the importance of building interactive relationship between JMOD/JSDF and JDIB, where former should continue
  to presenting new CONOPS and requirements for Japan's defense, and latter should be making unstinting effort to analyze global R&D trend
  and use of advanced technologies for national security purpose in response, and also welcome entry of new startup companies for the
  revitalization and evolution of the industrial base.

## GROWTH POTENTIAL FOR JAPAN'S DEFENSE MARKET

- Domestic Defense Budget(GDP 1% → 2%)
  - Sustainment, renewal and upgrade of legacy defense capability, as well as strengthening of logistical support capability and operational readiness, and making defense infrastructure base to be resilient
  - Increased investment to build capability in new domain area (Space, Cyber and Electromagnetic Spectrum)
  - Creating new defense business area from new CONOPS
  - Enhancing new defense capability buildup opportunities by having new startup from advanced technology area
  - Bringing new insight and knowledge from collaboration with academia for S&T research etc.

#### Oversea Market

- Use of Defense Transfer Project as diplomatic tool for "Proactive Contribution to Peace" policy
- Enhance G2G initiated Joint R&D/Joint Production opportunities
- Promote defense transfer and participate in oversea defense business for the sake of sustainment and strengthening of JDIB


### Multilateral Joint Project
